**ORDER:**

The Secretary, Ministry of Jal Shakti, Department of Water Resources, River Development & Ganga Rejuvenation, New Delhi, Government of India vide Letter 1<sup>st</sup> read above, has informed that as per the Dam Safety Act, 2021, every state is required to constitute the State Committee on Dam Safety and establish the State Dam Safety Organisation within a period of 180 days from the date of commencement of the said Act.

2. In the reference 3<sup>rd</sup> read above, the Engineer-in-Chief (General), Irrigation & CAD Department, Hyderabad inter alia has requested the Government for Establishment of (1) State Committee on Dam Safety (SCDS) (2) State Dam Safety Organization (SDSO), keeping in view of the provisions of Dam Safety Act, 2021.

3. After careful examination of the matter, in order to ensure proper inspection, operation, maintenance and surveillance of the dams in the state, Government hereby constitute the State Committee on Dam Safety and the State Dam Safety Organisation structure for Telangana State as respectively with the following members:

5. The state committee on Dam Safety and State Dam Safety Organization constituted as above will have to ensure action in a time bound manner as per the provisions contained in the Dam Safety Act, 2021 notified by the Government of India.

The personnel for the posts in State Dam Safety Organization various cadres shall be drafted by the Engineer-in-Chief (Admin), Irrigation & CAD Dept., on OD basis and their pay and allowances shall be drawn against the posts of their original postings. The existing Division of Central Designs Organisation which is incharge of Dam Safety subject would be co-opted into the SDSO to take up the activities required.

7. The Engineer-in-Chief (General), / Engineer-in-Chief (Admin) Irrigation & CAD Department, Hyderabad shall take necessary action in the matter accordingly.
