ORDER:

The River Development & Ganga Rejuvenation, Department of Water Resources, Ministry of Jal Shakti, Government of India in their DO letters 1st read above have informed that the Dam Safety Act, 2021 has been notified by the Central Government on 14-12-2021 and its provisions have come into force with effect from 30-12-2021. The Act provides for surveillance, inspection, operation and maintenance of the specified dams for prevention of dam failure related disasters and to provide for institutional mechanism to ensure the safe functioning and for matters connected therewith. According to Section (11) of Dam Safety Act, 2021, every State Government is required to constitute a State Committee on Dam Safety (SCDS) and establish a separate organization known as State Dam Safety Organization (SDSO), within a period of 180 days from the date of commencement of the above said act.

2. Accordingly, the Chief Engineer, Central Designs Organization in his letters 2nd to 6th read above, has requested the Government for constitution of State Committee on Dam Safety (SCDS) and State Dam Safety Organization (SDSO) according to the provisions of Dam Safety Act, 2021, duly redesignating the Chief Engineer, Hydrology as the Chief Engineer, State Dam Safety Organization & Hydrology.

3. Government after careful examination of the matter, hereby constitute (A) State Committee on Dam Safety (SCDS) and (B) State Dam Safety Organization (SDSO) for the State of Andhra Pradesh comprising the following members, duly redesignating the Chief Engineer, Hydrology as the Chief Engineer, State Dam Safety Organization & Hydrology:
