

No.AM2-201/1/2022-WR-WR: In exercise of the powers conferred under Section 14 of the Dam Safety Act, 2021, it is hereby notified for information of all concerned Stakeholders that a **State Dam Safety Organization (SDSO)** in respect of Manipur State is established comprising of the following Members/Officers/Engineers as detailed below with immediate effect and until further orders:

2. The State Dam Safety Dam Organization shall be responsible to, and report to the technical head of the Department dealing with Dam Safety. The Organization structure and work procedures of the State Dam Safety Organization shall be such as may be prescribed by the State Government. The Organization shall keep perpetual surveillance, carry out inspections and monitor the operation and maintenance of all specified dams falling under their jurisdiction to ensure continued safety of such specified dams and take such measures as may be necessary to address safety concerns that are noticed with a view to achieve satisfactory level of dam safety assurance as per such guidelines, standards and other directions on dam safety as may be specified by the regulations.

3. The above Organization may also co-opt any other Officers/Engineers as and when his/her service is required for performing/ executing the provisions contained in the above Dam Safety Act, 2021.
