The State Dam Safety Organisation (SDSO) shall act as per provision of the Dam Safety Act'2021 and shall be responsible to, and report to, the technical head of the Department dealing with Dam Safety. The work procedures of the State Dam Safety Organisation (SDSO) shall be such as may be prescribed by the State Government.

The State Dam Safety Organisation shall provide assistance to the State Committee as well as it's Committees & Sub-committees, in discharge of it's functions.
